





RELEASE AND WAIVER OF LIABILITY AGREEMENT

By checking the box below, you agree, warrant and covenant as follows:

I know that participating in **THE GREAT SANDPOINT FLATWATER REGATTA** (hereafter referred to as TGSFR) is a potentially hazardous activity. I know I should not enter and participate unless I am medically able and properly trained. I also know that, although law enforcement protection will be provided, there may be volunteers, spectators, kayakers, canoes and the like on the TGSFR course. With this understanding, I assume any and all risks associated with participating in the TGSFR including, but not limited to, tripping, falls, capsizing which comprise the TGSFR course, contact with other participants, volunteers, spectators or with canoes, kayakers and the like, the effects of the weather, including high heat, and/or humidity, and the condition of the TGSFR course, including, but not limited to, rough water and all such risks being known and appreciated by me. I agree to wear a Coast Guard approved PFD during the event. I also know that the TGSFR will close at 2:00 p.m. I agree that if I am on the TGSFR course at that time, I will move off the waterway to allow boating to proceed and will observe all waterway laws if I choose to complete the TGSFR course. Knowing and appreciating these risks and in consideration of your acceptance of my entry, I hereby for myself, my heirs, legal representatives, or anyone else claiming on my behalf, covenant not to sue, and waive, release and discharge the TGSFR committee, the Sandpoint Rotary, the City of Sandpoint, Bonner County, TGSFR volunteers and sponsors together with their agents, employees, assigns or anyone else acting for or on behalf of any of the foregoing entities, from any and all claims of liability for death, personal injury or damage of any kind or nature whatsoever arising out of or in the course of my participation in the TGSFR. This Release and Waiver extends to all claims of every kind whatsoever, foreseen or unforeseen, known or unknown.

I also understand that in the event that the TGSFR cannot be held as scheduled due to an act of God or other circumstances, I am not entitled to a refund of any money paid by me to participate. I also hereby consent to permit, and accept responsibility for emergency treatment in the event of injury or illness. I further grant full permission for the TGSFR committee to use any photographs, videotapes, motion pictures, recordings, or any other record of this event, which may include me, for any purpose.

AUTHORITY TO REGISTER AND/OR TO ACT AS AGENT.
You represent and warrant to the TGSFR committee that you have full legal authority to complete this registration. If you are registering third parties, you represent and warrant that you have been duly authorized to act as agent on behalf of such parties in performing this registration. By proceeding with this registration, you agree that the terms of this Liability and Waiver Agreement shall apply equally to you and to any third parties for whom you are acting as agent. You also agree that you have presented the full language of the terms of this Liability and Waiver Agreement to the third parties for whom you are acting as agent, and the third parties have agreed to be bound by said terms.
